To whom it may concern

CMC Klebetechnik is a company with a strong commitment to social responsibility. We believe that as a sustainable company, we need our suppliers and contractors to join us in this commitment, based on a shared set of values and principles.

There has been increased awareness of violence and human rights violations in the mining of certain minerals from the Democratic Republic of the Congo (DRC) and surrounding countries. CMC Klebetechnik shares the deep concern about sources of minerals from these conflict zones and is therefore committed to make its products DRC conflict-free and obtain full transparency throughout its supply chain.

CMC Klebetechnik supports the goals and objectives of Section 1502 of the Dodd-Frank Act, which aims to prevent the use of conflict minerals that directly or indirectly finance or benefit armed groups in the Democratic Republic of the Congo (DRC) or an adjoining country as defined in the Act (Conflict Region).

Conflict minerals include: columbite-tantalite (coltan) (i.e., tantalum), cassiterite (i.e., tin), gold, wolframite (i.e., tungsten) or their derivatives and could expand to include any other mineral or their derivative determined by the U.S. Secretary of State to be financing the DRC conflict.

Based upon information provided by our suppliers, CMC KLEBETECHNIK does not knowingly use metals derived from the Conflict Region that directly or indirectly benefit armed groups that are perpetrators of serious human rights abuses.

If such sources are Identified, CMC KLEBETECHNIK will take actions to remove them from its supply chain.
